CONDITIONS OF PARTICIPATION

- 1) **A bank draft for full payment payable to "Federation of Fur Manufacturers & Dealers (HK) Ltd."** (hereafter referred to as the 'Federation') **must accompany this application form.** This will entitle the applicant, if accepted, to take part in the 2023 Hong Kong International Fur & Fashion Fair to be held on 22 – 25 February 2023 at the Hong Kong Convention & Exhibition Centre.
- 2) Application forms must be forwarded to and bank drafts made payable to: (Any submitted application form without payment will not be entertained.)

The Federation assumes no responsibility for any loss of such application forms or payment drafts if sent by post.
- 3) This is the application form for both Hong Kong International Fur & Fashion Fair (physical Fair) and Virtual Fur Fair, once submitted applicant must abide by the rules and arrangement set by the Organizer. Upon any disputes, the Organizer's decision shall be final.
- 4) **Late application** submitted after closing date will be subject to a **surcharge** equivalent to 10% of the participation fee.
- 5) The Federation, as the Organizer, will deal with the application forms on a first-come-first-served basis. No definite right to take part can be presumed beforehand from the fact that an application form has been submitted and payment effected until participation has been confirmed in writing by the Organizer. The Organizer reserves its rights to reject any application in its absolute discretion and is under no obligation to give any reason therefor. The decision by the Organizer to accept or reject any such application shall be final.
- 6) Confirmation of acceptance will be sent to successful applicants by December. Balloting of booths will be held thereafter.
- 7) Should an applicant or an exhibitor withdraw from the Fair before or during the event or fail to abide by the "Conditions of Participation", the participation fee will be absolutely forfeited.
- 8) Exhibits in the booths throughout the Fair period must be relevant to the nature of business of the exhibitor concerned and must agree with the items listed in the application form.
- 9) **No booth can be shared between two or more separate companies. Since exhibiting right is non-transferable, only the exhibitor, whose name appears in the application form, has the right to exhibit in the allocated booth(s).**
- 10) There is strictly no retail sale allowed on the Fair ground throughout the Fair period.
- 11) Exhibitors are prohibited from holding their fashion shows in any function rooms or halls within the Hong Kong Convention & Exhibition Centre premises and in the nearby vicinity of the Centre. Display or distribution of any promotion materials are strictly limited to their own booths.
- 12) Exhibitors are prohibited to stage any house show in their booth(s) during the Fair.
- 13) Exhibitors must adhere to the regulations which apply at the exhibition venue and shall be liable for any damages caused to fittings in the exhibition premises and/or to the properties of other exhibitors.
- 14) Exhibitors shall be fully responsible for the exhibits inside their respective booths and are advised to provide adequate insurance for their exhibits and materials against any losses and/or damages caused while in transit to or from the exhibition venue or during the exhibition.
- 15) Each exhibitor shall appoint at least one senior executive to be in charge of and to assume responsibility of the booth(s) allocated during the Fair opening hours.
- 16) Exhibitors warrant that the exhibits and packages thereof and the publicity material or any other part of the display on the stand do not in any way whatever violate or infringe any third party's rights including all intellectual property rights including but not limited to trade marks, copyright, designs, names, and patents whether registered or otherwise. Exhibitors agree to fully indemnify the Organizer, its directors, servants or agents against all costs, expenses and damages arising from any third party's claim of infringements by the Exhibitor and/or the Organizer of such third party's rights.
- 17) Any additional expenses incurred by the Organizer for or on behalf of a specific exhibitor must be paid to the Organizer by the exhibitor within 14 days from the date of issue of the Organizer's debit note.
- 18) Force Majeure: In the event of compelling reasons not attributable to any fault its own, or in the case of Force Majeure of Acts of God, the Organizer has the right to cancel or postpone the Fair, or to shorten or prolong its intended duration without prior notice. Should the Fair be cancelled by the Organizer, the exhibitors will be refunded the payment made by him. In other cases, the exhibitor has no right to claim for any refund or compensation whatsoever.
- 19) Exhibitors agree to observe all deadlines set by the Organizer and act accordingly.
- 20) Exhibitors agree to abide by the decisions, rules and regulations of the Organizer.
- 21) Following the closure of the Fair, exhibitors will have to complete QUESTIONNAIRES on the volume of business successfully concluded during the Fair in order that a report can be drawn up and appropriate follow-up actions recommended.
- 22) **The Organizer reserves all rights to accept or disqualify any applicants or participants, and to amend this "Conditions of Participation" without prior notification.**
- 23) Violation of any of the preceding conditions will result in the exhibitor's instant cancellation of exhibiting right and prohibition against participation in future "Hong Kong International Fur & Fashion Fair".
